

CO., INC., above named owner, and under a contract of logging with said owner, employed, hired and contracted with IDAHO LEASE & RENTAL SYSTEMS, INC., a corporation, Claimant herein, for the leasing and hiring of equipment, tools and machinery for use in hauling, transporting and delivering from one place to another within the State of Washington, said saw logs, spars, piles and/or other timber, which leasing and hiring contracts were in writing, and were substantially as follows, to-wit:

1. Contract executed on or about May 1970 covering one Merritt TimberMaster Log Loader with engine for \$1450.00 per month.
2. Contract executed on or about December 1966 covering one Port-a-Spar Tree Yards for \$2047.00 per month.
3. Contract executed on or about August 1968 covering Caterpillar Model Tractor and equipment for \$1300.00 per month.
4. Contract executed on or about March 1967 covering Port-a-Spar Tree Yards and equipment on motor chassis for \$7100.00 per month.
5. Contract executed on or about June 1968 covering four (4) Peterbilt Trucks and Peerless Log Trailers for \$1360.00 per month.
6. Contract executed on or about July 1970 covering one D-8 Caterpillar Tractor with equipment for \$2550.00 per month.

The said RALPH LYONS and BETTY LYONS dba RALPH LYONS LOGGING COMPANY as agent and representative of RAINIER MFG. CO., INC. and while under and pursuant to the contract of logging with such owner, agreed to pay IDAHO LEASE & RENTAL SYSTEMS, INC., Claimant herein, for all such charges and costs for the leasing and use of its equipment, tools and machinery aforesaid; that said contracts and agreements on the part of said Claimant have been faithfully performed and fully complied with on the part of Claimant; that said equipment, tools and machinery were delivered as agreed and set forth and have been in continuous use since delivery by said RALPH LYONS and BETTY LYONS dba RALPH LYONS LOGGING COMPANY; that the use of said machinery, tools and equipment under said agreement was terminated and closed on September 25, 1970, and thirty (30) days have not elapsed since said time; that the amount of Claimant's demand for said service, costs and charges now remaining unpaid is \$44,563.00, a part of which has been paid, and there is now due and remaining unpaid thereon after deducting all just credits and offsets the sum of \$4,563.00, in which amount IDAHO LEASE & RENTAL SYSTEMS, INC., Claimant herein, claims a lien upon said saw logs, spars, piles and/or other timber.


