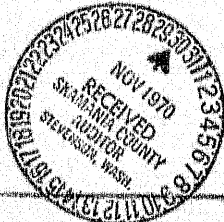

NOTICE IS HEREBY GIVEN that Randle Hoxit
of Cowlitz County, State of Washington, claims a lien upon a
certain quantity of logs
being about 500,000 board feet in quantity, which were cut or manufac-
tured in Skamania County, State of Washington, now lying in
Sections 26 and 35, Township Eight North, Range Six East, Skamania
County, Washington, for labor performed upon and
assistance rendered in falling and bucking said
logs; that the name of the owner or
reputed owner is Rainier Manufacturing Co.; that
Henderson Howard employed said Randle Hoxit
to perform such labor and render
such assistance upon the following terms and conditions, to-wit:
\$2.75 per 1,000 board feet

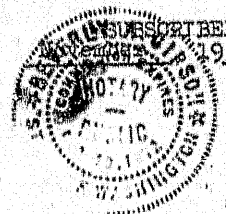
The said Henderson Howard, Randle Hoxit, for such labor and assistance \$2.75 per 1,000 board feet; that said contract has been faithfully performed and fully complied with on the part of said Randle Hoxit, who performed labor upon and assisted in felling and bucking said logs for the period of approximately three weeks; that said labor and assistance were so performed and rendered upon said logs, between the 21st day of October, 1970, and the 5th day of November, 1970 and the rendition of said service was closed on the 5th day of November, 1970, and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is ONE THOUSAND THREE HUNDRED SEVENTY-FIVE (\$1,375.00) Dollars; that no part thereof has been paid except none and there is now due and remaining unpaid to claimant, after deducting all just credits and offsets, the sum of ONE THOUSAND THREE HUNDRED SEVENTY-FIVE (\$1,375.00) Dollars, in which amount he claims a lien upon said logs. The said Randle Hoxit, also claim a lien on all said logs owned by said Henderson Howard, Rainier Mfg Co & John Zumwalt of said county to secure payment for the work and labor performed in obtaining and securing the said logs, spurs, piles or other timber, lumber or materials herein described.

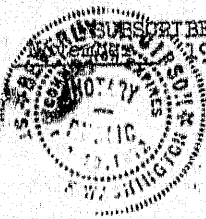
