NOTICE OF CLAIM OF LIEN

NOTICE IS HEREBY GIVEN that on March 14, 1974, at the request of LOUIS E. BARTH, proprietor of the NORTH BONNEVILLE FOOD LOCKER, STEVEN WHITE commenced to perform labor and furnish material to be used upon the refrigeration system of the NORTH BONNEVILLE FOOD LOCKER, North Bonneville, Washington, located on real estate situated in the County of Skamania, State of Washington and described as follows:

Beginning at a point on the southerly line of the Evergreen Highway which is south 1,257 feet and west 38.93 feet from the common corner of Sections 15, 16, 21 and 22, Township 2 North, Range 7 E. W. M.; thence south 81° 00' east 50 feet; thence south 09° 00' west 280 feet to the initial point of the tract hereby described; thence south 81° east 100 feet; thence south 09° west 68 feet to the northerly line of the Spokane, Portland and Seattle Railway Company right of way; thence westerly along the northerly line of said railway right of way to a point south 09° west of the initial point; thence north 09° east 62 feet to the initial point; said tract being designated as Lot 12 of Block Seven of the unrecorded plat of the Town of North Bonneville, Washington;

of which the property the owners, or reputed owners, are LOUIS E. BARTH and LENA W. BARTH, his wife, the performance of which labor and furnishing of materials ceased on the 17th day of June, 1974; that the labor performed and material furnished was of the value of Three Hundred Eighteen Dollars and Seven Cents (\$318.07), for which labor and material the undersigned claims as lien upon the property herein described for the sum of \$318.07.
