Gentlemen:

When and if we acquire the timber on the Polar Star and Minnie Lee groups of patented mining claims, description below, located in Skamania County, State of Washington, in the Mt. St. Helens Mining District, we agree to build a road to and into said Polar Star properties.

It is understood that the purpose of the road is to enable us to cut and remove timber from said properties, and that you, and your assigns, are to have the right of joint use of the road for hauling mine supplies and ores or concentrates, at a charge of 25 cents per ton. We also agree to grant you joint use of other roads of the Company in said mining district on the above mentioned rate.

It is understood that use of such roads by you is not to interfere with our logging operations and that should such interference develop, that then in that case you will either discontinue use of such roads until they are no longer required for logging, or transport your supplies and materials at a time and in a way which will not interfere with such logging operations.
