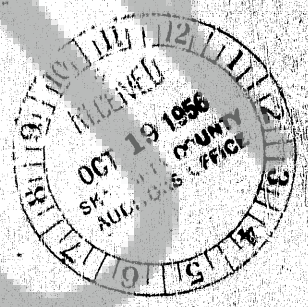
STATEMENT AND CLAIM  
OF LIEN

NOTICE IS HEREBY GIVEN that the Employment Security Department of the State of Washington claims a lien prior to all other liens or claims and on a par with prior tax liens against the following described property of the above named employer which property is now located in the County of Skamania State of Washington, to-wit:
