This land has been classified as forest land as of January 1, 1975 and will continue to be assessed as CLASSIFIED POREST LAND until removal of such classification for one of the following reasons: (a) Notice from owner to remove classification; (b) Sale to an ownership making land exempt from taxation; (c) Determination by assessor that land is no longer primarily devoted to, and used for, growing and harvesting timber; (d) Determination that a higher and metter use exists for the land than growing and harvesting timber. 
