ASSESSOR'S CLASSIFICATION OF FOREST LAN

- (a) Notice arem owner to remove classification;
- (a) Determination by assessor that land is no longer primarily devoted x:, and used for, growing and harvesting timber;
- (d) Determination that a higher and better use exists for the land than growing and harvesting timber.

Upon removal of this land as CLASSIFIED FOREST LAND, a compensating tax shall be imposed upon the land based upon the following formulary procedure:

The compensating tax shall not be imposed if the removal resulted solely from:

- (a) Transfer to government entity in exchange for other forest land;
- (b) A taking or transfer to entity having power of eminent domain;
- (t) Sale of land within two years after death of owner owning at least fifty percent (50%) interest in the land.

If it is not your desire to have such land assessed and valued as classified forest rand, you must give the assessor's office written notice thereof, on or before March 31, 1975. (See written notice below.)
