Beginning in 1975, the county assessor is directed by RCW Chapter 187 to assess and value as CLASSIFIED FOREST LAND, all lands of 30 or more acres which are primarily devoted to, and unau for, the growing and harvesting of timber.

This land has been <u>charaffied</u> as <u>forest land</u> as of January 1, 1975 and will continue to be assessed as <u>GLASSIFIED POREST LAGU</u> until removal of such classification for one of the following removes:

- (a) Notice from owner to remove classification;
- (b) late to en ownership making land exempt from taxation;
- (c) Determination by assessor that land is no longer primarily devoted to, and used for, growing and harvesting
- (6) Determination that a higher and better use exists for the land than growing and harvesting timber.

Upon removal of this Thind as CLASSIFIED FOREST LAND, a compensating tax shall be imposed upon the land based upon the following formulary procedure:

The compensating tax shall not be impresed if the removal resulted rolely from:

- (a) Transfer to government entity in exchange for other forest land;
- (b) A taking or transfer to entity having power of emine it domain;
- (c) Sale of land within two years after death of owner owning at least fifty percent (50%) interest in the land.
