- (b) Sale to an emperable making land exempt from taxation;

- (d) Determination that a higher and better use stists for the land than growing and harvesting timber.

- (b) A taking or transfer to entity having power of eminent domain;
- (c) Sale of land within two years after de(of owner owning at least fifty percent (50%) interest in the land.
