ASSESSOR'S CLAUSIFICATION OF POREST LAND

Beginning in 1975, the county assessor is directed by RCW Chapter 187 to assess and value as CLASSIFIED POREST LAND, all lands of 20 or more acres which are primarily devoted to, and used for, the growing and harvesting of timber.

This land has been classified as forest land as of January 1, 1975 and will continue to be assessed as CLASSIFIED POREST LAND until removal of such classification for one of the following reasons:

- (a) Notice from owner to remove classification;
- (h) Sale to an ownership makin, land exempt from taxation;
- (c) Determination by assessor that land is no longer primarily devoted to, and used for, growing and harvesti g timber:
- (d) Determination that a higher and better use exists for the land than growing and hervesting tumber.

Upon removal of this land as CLASSIFIED FOREST LAND, a compensating tax shall be imposed upon the land based upon the following formulary procedure

The compensating tax shall not be imposed if the removal resulted solely from:

- (a) Transfer to government entity in exchange for other forest land;
- (b) A taking or transfer to entity having power of eminent domain;
- (4) Sale of land within two years after death of owner timing at least fifty percent (50%) interest in the land.

IF YOU DO NOT WANT THIS LAND CLASSIFIED AS POREST LAND, PLEASE NOTE:

If it is not your desire to have such land assessed and valued as classified forest land, you must give the assess a soffice written notice thereof, on or lafore March 31, 1975. (See written notice below.)
