Beginning in 1975, the county assessor is directed by RCW Chapter 187 to assess and value as <u>CLASSIPIED POPPAY LAND</u>, all lands of 20 or more acres which are primarily devoted to, and used for, the growing and harvesting of timber.

This land has been <u>classified</u> as <u>forest land</u> as of January 1, 1975 and will sontinue to be assessed as <u>CLASSIFIED</u> <u>POPEST LAND</u> until removal of such classification for one of the following reasons:

- (a) Hotice from owner to remove classification;
- (b) Sale to an ownership making land exempt from taxation;
- (c) Determination of assessor that land is no longer primarily devoted to, and wand for, growing and harvesting
- (d) Extermination that a higher and better use exists for the land than growing and harvesting timber.

Upon removal of this land as CLASSIFIED FOREST LARD, a compensating tax shall be imposed upon the land based upon the following formulary procedure:

The compensating tax shall not be imposed if the removal resulted solely from:

- (a) Transfer to government entity in exchange for other forest land;
- (b) A taking or transfer to entity having power of eminent domain;
- (c) Sal of land within two years after death of owner owning at legat fifty percent (50%) interest in the land.
