ASSESSOR'S CLASSIFICATION OF POREST LAND

Sec. 5. RCW Chapter 187, Laws of 1974 let Ex. Sess.

Beginning in 1975, the county assessor is directed by RCW Chapter 187 to assess and value as CLASSIFIED POREST LAND, all lands of 20 or more acres which are primarily devoted to, and used for, the growing and harvesting of timber.

This land has been <u>classified</u> as <u>forest land</u> as of January 1, 1974 and will continue to be assessed. <u>CLASSIFIED</u> <u>POREST LAND</u> until removal of such classification for one of the following reasons:

- (a) Notice from owner to remove classification;
- (b) Sale 'o an ownership mawing land exempt from taxation;
- (e) Deter ination by assessor that land is no longer primarily devoted to, and used for, growing and harvesting
- (d) Detrainstion that a higher and better use exists for the land then growing and harvesting timber.

Upon removal of this land as <u>CLASSIFIED FOREST LAND</u>, a compensating tax shall be imposed upon the land based upon the following formulary procedure:

The compensating tax shall not be imposed if the removal resulted solely from:

- (a) Transfer to government entity in exchange for other forest land;
- (b) A taking or transfer to entity having power of eminent domain;
- (c) Sale of land within two years after death of owner owning at least fifty percent (50%) interest in the land.

If it is not your desire to have such land assessed and valued as classified forest land, you must give the assessor's office written notice thereof, on or bef e March 31, 1975. (See written notice below.)
