Reginning to 1975, the county camessor is directed by RCM Chapter 187 to assess and value as CLASSIFIED FOREST LAND, all lands of 20 or per, acres which are privarily devoted to, and used for, the growing and barventing of winder.

This land has been classified as forest land as of January 1, 1975 and will combinue to be assessed as CLASSIFIED PRESS LAND until removal of such classification for one of the following reasons:

- (a) Hottee from owner to remove classification;
- (b) Sale . an owner hip making land exempt from taxation;
- (c) Determination by assessor that land is no longer primarily devoted to, and used for, growing and harvesting
- (d) Determination that a higher and better use exists for the land than growing and harvesting timber.

- (b) A taking or transfer to entity having power of eminent domain;
- (c) Sale of land within two years after death of owner owning at least fifty percent (50%) interest in the land
