

GWNER:

Beginning in 1975, the county assessor is directed by RCW Chapter 187 to assess and value as CLASSIFIED FOREST LAND, all lends of 20 or more acres which are primarily devoted to, and used for, the growing and harvesting of timber.

This fand has been <u>classified</u> as forest land as of January 1, 1975 and will continue to be assessed as <u>CLANSIFIED</u> <u>POREST LAND</u> until removal of such classification for one of the following reasons:

- (a) Notice from owner to remove classification;
- (b) Sale to an ownership making land exempt from taxation;
- (c) betermination by essessor that land is no longer primarily devoted to, and used for, growing and harvesting
- (d) Betermination that a higher and better use exists for the land than growing and larvesting to ber-

The compensating tax shall not be imponed if the removal resulted solely from:

- (a) Transfer to government entity in exchange for other rorest land;
- (b) A taking or transfer to entity having power of eminent domain;
- (c) Sale of land within two years after death of owner owning at least flity percent (50%) interest in the land.
