County of Skamania, ss. Please take notice: 1. That H.L. Gilbert of Portland, Oregon here claim the use of the water lying being and flowing in the North fork of Lewis River in Skamania County Washington to the extent of two thousand (2000) cubic feet per cent of Time.

2. It is intended to divert said water at a point where this notice is posted which place of posting is on the west bank of said North Fork of Lewis River in Lot one Section 26 Township 7 North Range 6 East W.M. in said Skamania Co. Wash.

3. The purpose for which said water is intended to be used is for manufacture and development of electric power and for irrigation of lands along said river from the place of diversion to the place of use and where said water will be returned again to the bed of the river. The place of intended use for the manufacture and development of electric power is at a point about nine miles down the stream from said point of diversion in Sec. 28 To. 7 N. & R. 5 Ea W.M. in said Skamania county where said power can most conveniently and principally applied.

4. It is intended to divert said water by means of a dam at the point of diversion and to carry said water by means of ditch flume and pipe line to the point of designation for its use.

5. It is intended to have work for diversion and use of said water as aforesaid completed within five years from the date of posting this notice.
