Notice is hereby given that the undersigned citizen of the United States has this day in conformity with the Acts of Congress, the laws of the state of Washington and the local customs of said State claimed by taken possession of, located and appropriated and do hereby claim take possession and appropriate two hundred cubic feet per second of time of the waters lying being and flowing in the stream known and named Niggerhead Creek which said stream is situated in the County of Skamania State of Washington, the same being the stream on the right bank of which this notice is posted. This notice is posted on a large hemlock tree about 3 miles above the confluence of the Niggerhead and McCoy Creek.
