Beginning in 1975, the county assesser is directed by RCW Chapter 187 to assess and value as CLASSIFIED FOREST LAND, all lands of 20 or more acres which re primarily devoted , and used for, the growing and burveating of timber.

- (b) Sale to an ownership making land exempt from taxation;
- (c) Determination by assessor that .am. 's no longer primarily devoted to, and used for, growing and harvesting timber:
- (d) Determination that a higher and better use exists for the land than growing and harvesting timber.

Upon removal of this land as CLASSIFIED FOREST LAND, a compensating tax shall be imposed upon the land based upon the following formulary procedure:
