## Notice of Water Right

Notice is hereby given that the Northwestern Electric Company a corporation organized incorporated and existing under the laws of the State of Washington has claimed taken possession of located and appropriated and does hereby claim take possession of locate and appropriate two thousand (2000) cubic ft per second of time of the water lying being and flowing in the stream known and named White Salmon River, the same being the boundary line between Klickitat and Skamania counties State of Washington and being the atream on the east bank of which this notice is posted. This Notice is posted on a 14 " Oak tree on the east bank of the white Salmon River in the NW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 10 T 3 N.R. 10 E.W.M. The purpose for which this water is claimed and appropriated and for which the same will be used are for mining, for supplying cities and towns and villages with water, for water works for irrigation purposes and in creating water power for the production and for operating water power to be used for manufacturing purposes and in creating a water power for the production of electricity and electric power to be used for manufacturing purposes and for supplying cities towns and villages with light and for supplying power for the operation of railroads and other means of transportation and for supplying electricity for heat and domestic purposes. Notice is hereby further given that the undersigned pursuant to this appropriation intends to construct a dam at or near the point where this notice is posted across the said White Salmon River not to exceed 150 ft in height above high water and to operate thereby a storage reservoir and to further use said dam for diverting the water herein claimed from the White Salmon River and said water will be used directly at the dam or will be carried down stream on the east side thereof by means of flumes canals or pipes a distance not to exceed one mile and will there be used for the purposes hereinbefore mentioned and then returned to the river. Reference is hereby made to a certain notice posted at this same place on the 16th day of March 1911 by the Northwestern Electric Company, this present notice being intended to maintain the rights acquired in the first notice posted and further notice is hereby given that continuous work and diligent work has been maintained in acquiring the necessary rights for construction. This notice has been executed in triplicate and one copy hereof will be filed in the office of the Auditor of Klickitat county and one in the office of the Auditor for
