

Notice of Appropriation of Water

Notice is hereby given that the Shipherd Land, Light and Power company, a corporation of the State of Washington, with its principal place of business at Carson, Skamania County, Washington, hereby appropriates and claims nine hundred and fifty (950.) cubic feet per second of the water of Wind River, Skamania County, Washington to be diverted from the right bank of said stream at a point which bears about thirteen hundred (1300) feet south from the one-quarter section corner between sections 16 and 21, Township 3 North Range eight East Willamette meridian, Skamania County, Washington. The means by which it is intended to divert said water is by means of a diversion dam, ditch, flume, pipe and canal, which ditch and canal extends in a southerly direction from the said point of diversion, and will be constructed five feet wide at the bottom and eight feet wide at the water surface, and to carry four feet depth of water, and that the water is to be returned to the stream of Wind River in Section 21, Township 3 North Range 8 East, and the available fall is fifty (50) feet. That the purpose for which said water is appropriated is for mining and manufacturing purposes and for power purposes and to generate electrical power, and that the place or places as near as may be of intended use of the said water and purposes to which it is to be devoted, is in Carson, Skamania County Washington, and to the surrounding country and neighborhood, and other places in Skamania County Washington.

This Notice is posted and placed at the point of diversion to-wit: In the North $\frac{1}{2}$ of Section 21, Township 3 North Range 8 East Willamette meridian, Skamania County Washington.
