Beginning in 1 '5, the county assessor is directed by RCW Chapter 187 to assess and value as CLASSIF'ED POREST LAND, all lands of 20 or more acres which are primarily devoted to, and used for, the growing and have esting of times.

This land has been classified as forest land as of January 1, 1975 and will continue to be assessed as CLASSIFIED FOREST LAND until removal of such classification for one of the collowing removal.

- (a) Notice from owner to remove classification;
- (b) Sale to an o-mership making land exempt from taxation;
- (a) Determination by assessor that land is no longer primarily devoted to, and uses for, growing and barvesting
- (d) Determinal on that a higher and better use exists for the land than growing and horvesting timber.

The compensating tax shall not be imposed : " the removel resulted solely from:

- (a) Transfer to government entity in . hange for other forest land;
- (b) A taking or transfer to entity wing power of eminent domain;
- (c) Sale of land within two years after death of owner owning at least fifty persent (50%) interest in the land.
