## SUPPLEMENTAL NOTICE OF WATER RIGHT. ✓

TO ALL CONCERNED NOTICE IS HEREBY GIVEN, that the undersigned, Eugen Kuhne, of White Salmon, Washington, being the assignee by assignment dated September 8, 1911, of R.D. Cameron and Mrs. R.D. Cameron of all their right to appropriate water from the source known as Big Spring, under notice of appropriation of water made by said R.D. Cameron and Mrs. R.D. Cameron May 18, 1904, and filed and recorded in the office of the County Auditor of Skamania County, Washington, at page 25, Book "E" of Miscellaneous Records; and the said Eugen Kuhne, for the purpose of more particularly and definitely describing the amount of water claimed from the said Big Spring, and more particularly and definitely describing the point of diversion and the place of use of said water: hereby claims the use of all the waters of said Big Spring and in the stream flowing therefrom, to the extent of thirty-six cubic feet of water per second of time.

It is intended to divert said water from said stream at or near the point where a copy of this notice is posted, and more definitely described as follows: at or near the head-gate located at the point on said stream about mid way between North & South line of the NE $\frac{1}{4}$  of NW $\frac{1}{4}$  of Sec. 10 T. 3 N. R. 10 E.W.M. from which corner of section 10 in T 3 N. R 10 E.W.M. bears in a northeasterly direction about 100 rods distant and said water shall be conveyed from said head gate by means of a flume and pipe of sufficient size and carrying capacity to carry said water to said premises.

The purpose for which said water is intended to be used is for household, domestic and irrigation purposes, and the place of intended use is upon the farms and premises of

the said Eugen Kuhne, more particularly described as follows: The NE $\frac{1}{4}$  of NE $\frac{1}{4}$ , the SE $\frac{1}{4}$  of NE $\frac{1}{4}$  Sec.10 & W $\frac{1}{2}$  of NW $\frac{1}{4}$  Sec.11 all in T 3 N.R.10 E.W.M.

It is intended to divert said water by means of flumes, pipes or ditches.
