

Skamania County to Skamania Co-operative
Telephone Association.

In the matter of the petition of the Skamania Co-operative Telephone Association, a Washington corporation, for a franchise to use the roads of Skamania County, Washington, for the purpose of maintaining thereon their present telephone system, and to construct thereon other telephone lines.

Now on this 6th day of January 1909 this matter comes before the Board of County Commissioners of Skamania county for hearing pursuant to notice heretofore given, and it appearing to the said Board that due and legal notice of the hearing was given as is required by law for the required length of time, and the petitioner above named appearing by and through its attorney, Raymond C. Sly, and all things being in readiness, the hearing was proceeded with.

And it appearing to the said Board that the erection and maintenance of the petitioner's telephone system in Skamania County is a public improvement and benefit, and it appearing that it is necessary that the petitioner use the public roads for the purpose of erecting and maintaining thereon its poles, lines and other appurtenances, the said Board of Commissioners, being fully advised in the matter and understanding all and singular the law and facts in regard thereto, did determine that the petition of the said Skamania Co-operative Telephone Association for the said franchise be granted.

And it is ordered and adjudged, and this does order and adjudge, that the Skamania Co-operative Telephone Association, a corporation duly organized and doing business under the laws of the state of Washington, and its successors and assigns, be and are hereby granted a franchise to use the public roads and highways, dedicated or established in Skamania county, Washington, for the purpose of maintaining and operating thereon its present telephone system and to construct maintain and operate thereon other and further telephone lines or systems of telephone lines.

And for the purpose of aforesaid the said company, or its successors or assigns, shall have the right and privilege, to erect and maintain upon the said roads and highways its poles, wires and other appliances and appurtenances, and to lay underground conduits in the said roads and highways.

Provided, however, that the said poles, wires, and other appliances and appurtenances shall be so placed as not to interfere with the proper use of the said roads and highways in the usual methods of travel and public use thereof, and shall be subject to the approval of the county engineer.

And provided further, that whenever the said company shall make any excavation for the purpose of erecting poles or other appliance in the said roads or highways, the said road or highway shall be put in the same good condition thereafter as before such excavation was made.

And it is ordered, and this does order that the said franchise be and the

same is hereby granted to the said SKAMANIA CO-OPERATIVE TELEPHONE ASSOCIATION, or its successors or assigns, for the period of fifty years from the date hereof.
