Please take notice:

1. That H. L. Gilbert of Portland, Multnomah County, Oregon hereby claims the use of
the water lying, being and flowing in Swift Creek in Skamania County, Washington to the
extent of Five Hundred (500) cubic feet of water per second of time, to be taken from
both the East and West forks.
2. It is intended to divert said water at a point where this notice is posted, said
point being on the right bank of said ^{the East Fork of} Swift Creek in the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 16
Tp. 7 North of Range 5 East of the Willamette Meridian. 100 ft. South of the Section
line between Sections 9 and 16.
3. The purpose for which said water is to be used is for the development of electric
power and for irrigation. The place of intended use is at a point near the mouth of
said Swift Creek in Section 28, Tp. 7 North, Range 5 East of Willamette Meridian, where

said water will be returned to the North Fork of the Lewis River.

4. It is intended to divert said water by means of a dam at the point of diversion and to convey said water by means a ditch, flume or pipe to the point of intended use.

5. It is intended to have works for the diversion and use of said water completed within 5 years from this date.
