## NOTICE OF RESERVOIR SITE LOCATION

NOTICE IS HEREBY GIVEN That the undersigned citizen of the United States in conformity with the Acts of Congress, the laws of the State of Washington, and the local customs of said State, has claimed, taken possession of, located and appropriated, and does hereby claim, take possession of, locate and appropriate the valley of the Cispus River as a Resertir site. Said reservoir site to begin about i mile below the mouth of the muddy fork on the main dispus River near the point where a copy of this notice is posted and said reservoir site to extend up the stream in the valley and drainage of the Cispus about six miles to a point there what is known as the Klickitat trail crosses the Cispus river. The intent being to store in said site ten thousand million cubic feet of water (10,000,000,000) That portion of the valley of the Cispus River covered by thes Reservoir site lies in Skamania County State of Washington. The purposes for which said Reservoir site is claimed and appropriated, and for which the same will be used is to store water to be used for mining, milli g, manufacturing, industrial, irrigation, and for creating a water power to be used for mining, milling, manufacturing, industrial, irrigation purposes, and for creating a water power for the production of electricity to be used for all public, domestic and industrial uses; and for creating electricity for the purpose of supplying cities, towns and villages with light, hear, and power; and for furnishing public service corporations with light, heat, and power; and for all otherpublic uses to which electricity can be applied. For supplying cities, towns and villages with water, and for water works, and for irrigating lands, and for creating electricity for all public and domestic uses whatsoever. For supplying power for the operation of zailroads and other means of transportation, and for all and every public use and service to which water, en water power, or electricity generated from water power can in any way be used.

Notice is hereby further given that the underwigned, pursuant to this apprepriation, intends to store 10,000,000,000 cubic feet of water in said reservoir site and to erect storage dams near the point where a copy of this notice is posted; and to cause the water so stored to flow therefrom in a westerly direction about 15 miles to the poper

The means by which it is intended to store said water are dams, ditches, flumes and conduits. The places where it is intended to use said water is about 15 miles in a westerly direction from the point of intake about & mile below the muddy fork. A copy of this notice is posted on a small cedar tree on the left shore at the head of the first fails below the maddy fork.
