NOTICE OF WATER RIGHT

Notice is hereby given that the undersigned claims the water of a certain spring located in SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 27, Twp.2 North of Range 6 East of Willamette Meridian located about 20 rods North of the North line of the SW $\frac{1}{4}$ of said section 27, to the extent of one cubic foot per second of time. The purpose for which said water is to be used is for domestic purposes, irrigation and storage upon the Southwest quarter of Section 27 in Township two North of Range Six East of W.M. The water is to be diverted by means of ditch and pipe line. The point of diversion to be at North line of NW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 27, Twp.2 N.R.6 E. of W.M.
