ORDER

Declaring result of canvass of Election and of Organization.

On this 7th day of August, A.D.1916, the same being the first day of the regular August, 1916, session of this Board came on regularly for hearing the matter of canvassing the votes cash at the special election held on July 22, 1916, in the proposed irrigation district, as hereinafter described, for the purpose of determining whether or not the said proposed Underwood Irrigation District should be organized under the provisions of Chapter VII of Title XLVIII.of Remington's 1915 Codes and Statutes of Washington, being Sections 6416 to 6494, both inclusive, of said Codes and Statutes; and it appearing that on the second Monday next succeeding such election to-wit: Monday, July 31, 1926, no meeting of this Board was held, that no meeting of this board has been held since that date, and that this is the first session of this Board at which the canvass of said election could be made and had, and this Board now having duly and regularly and in the manner required by law canvassed the voles cast at said election from the returns forwarded to the Auditor of this County by the Election Board conducting such election, and having fully considered the returns of said election, and being fully advised in the premises, FINDS AND DECIDES

of Skamania County, Washington, he being ex officio the clerk of the Board of County Jommissioners in the manner required by law and pursuant to the previous order of this Board made and entered herein on July 3, 1916, such notice being duly and regularly published ance a week for a least two weeks prior to said election in the "Skamania County Picneer" a weekly newspaper of general circulation, published in Skamania County, Washington, that being the county where the petition for said proposed irrigation district was presented, and no portion of said proposed district lying within any other county, to-wit: the same being published July 6, July 13, and July 20,1916, which notice as published described the boundaries of said proposed irrigation district as established by said previous order of this Board, gave the name designated for said proposed district, to-wit: "Underwood Irrigation District" stated the purposes and objects of said election, and required the electors at said election to cast ballots containing the words "Irrigation District Yes" and "Irrigation District No" and also the names of the persons to be voted as directors of said district.

Second: That said election was conducted in all things in accordance with the law applicable thereto and provided therefor.

Third: That upon the canvassing of the votes cast at said election it appears that at least two thirds (2/3) of all the votes cast are "Irrigation District Yes" to-wit: that at said election there were nine (9) votes cast in all, that Nine (9) votes were cast "Irrigation District -Yes" and no votes were cast "Irrigation District No." That at said election nine (9) votes fast for H.C.Lowden as director, Nine (9) votes were cast for H.A.Hussey as director and nine (9) votes were cast for #.A.Cooper, as director, and no other person received any votes for the office of director.

NOW THEREFORE, It is hereby ORDERED, ADJUDGED, DECLARED AND DECREED by this board of County Commissioners:

(1) That the territory hereinafter described, pursuant to the law aforesaid and the proceedings heretofore had and taken, has been duly organized into an irrigation district, under the name and styls, and the same shall hereafter be known as "Underwood Irrigation District" the boundaries of which are and shall be as follows:

Commencing at the southeast corner of section 15, township 3 North, Range 10 E.W.M.

thence east along the section line between sections 14 and 23 to the White Salmon river; thence Northerly following the course of said river to the quarter section line running east and west through said section 14; thence west along said quarter section line to the west line of said section 14; thence south along the west line of said sections 14; thence west along the west line of said sections 14; thence west along the west line of said sections 14; thence west along the west line of said Rine land, 80 rods, more or less, to the northwest corner thereof; thence south along the west line of said Rine land, 80 rods, more or less, to the southwest corner thereof, the same being on the section line between sections 15 and 22; thence west along said section line 80 rods, more or less to the southeast corner of theland of one, Hedrick; thence North along the East

line of said Hedrick land, 40 rods, more or less, to the northeast corner thereof; thence west along the north line of said Hedrick land, 60 rods, more or less, to the Northwest corner thereof; thence south along the west line of said Hedrick land, 40 rods, more or less, to the southwest corner thereof, and 60 the section line between said sections 15 and 22; thence east along said section line 80 rods, more or less to the quarter corner on the south line of said section 15; thence south along the quarter section line running north and south ghrough said section 22 to the southwest corner of the north half of lot 3 of said section 22; thence east along the south line of said north half of lot 3, and continuing east along the south line of the north half of lot 4 of said section 22, to the east line of said section 22 thence north along the east line of said section 22 to the southeast corner of said section 15, two the place of beginning, and there ending; containing 311 screes, more or less.

- (2) The following named persons received the highest number of votes for the office of director, and each of them are hereby declared and decreed duly elected to the office of director as follows, N.C.Lowden, H.A. Hussey and G.A. Cooper.
- (3) That the clerk of this Board shall issue to each of the officers above named a certificate of his said election.
- (4) That a copy of this order, duly certified, shall be filed with and recorded in the office of the County Auditor, of Skamania County, Washington.
- (5) That the directors elected aforesaid shall be entitled to enter-immediately upon the duties of their said offices upon qualifying therefor in accordance with law, and shall hold their said offices until their successors are elected and qualified.
