NOTICE OF WATER RIGHT.

NOTICE IS HEREBY GIVEN ;

To all concerned.

That Martin H. Thode for Wicky Creek Company, a corporation of Guler, Washington, being first duly sworn deposes and says that he hereby claims, appropriate and files on the water flowing in Wicky Creek to the extent of 100 cubic feet per second.

It is intended to divert said water at or near the point where a copy of this notice is posted, and more definitely described as follows: About 60 rods up stream from the point where the said Wicky Creek empties into the White Salmon River. Said location being in the SW quarter of section 22, ^{T. 7} N. R. 10 E. W. M. Skamania County, Washington.

The purposes for which said water is intended to be used is for Domestic Irrigation and the development of Power. The place of intended use is in township 6 &

7 N.R.10 E.W.M.

It is intended to divert said water by means of dams, flumes, ditches, hydraulic rams or pumps.
