NOTICE IS HEREBY GIVEN, That THE UNDERSIGNED CITIZENS OF THE UNITED STATES, in conformity with the Acts of Congress, the laws of the State of Washington, and the local customs of said State, has claimed, taken possession of, located appropriated and does hereby claim, take possession of, locate and appropriate TWO THOUSAND cubic feet per second of time of the waters lying, being and flowing in the stream known as and named Cispus River, which said stream is situated in the County of Skamania, in said State of Washington, the same being the stream on the left bank of which this notice is posted.

This notice is posted on a small cedar tree at the head of the first falls below the confluence of the muddy fork with the main Cispus river.
