SKAMANIA COUNTY GAME COMMISSION to THE PUBLIC.

Section 5364- I Rammingtons & Ballingers
Code, Statutes of Washington.

Whenever any species of game birds shall have been liberated in any County of this State by the County Game Commission, such commissions, may with the consent of the owners of the land, close all or any portion of the County by giving notice thereof by publication for three successive weeks in a newspaper published in the County and thereafter it shall be unlawful to hunt, take, kill or molest, any such species of birds within such designated area for not to exceed three (3) years after the date of the first publication of such notice. Any person violating any of the provisions of, this section shall be guilty of a misdemeanor,

In accordance with the above invested authority, we, the game Commission of Skamania County, Washington, do hereby establish and declare the territory within the corporate limits of the Town of Stevenson to be and is hereby a closed territory for the hunting of any and all game, for three years from date.
