The North East Quarter (N.E. 1/4) of the North West Quarter N.W. 1/4 And the North West Quarter N.W. 1/4 of the North East Quarter N.E. 1/4 of Section Two (2) in Township One (1) North of Range Five (5) East of the Willamette Meridian containing Eighty  $\frac{36}{100}$  ( $80 \frac{36}{100}$ ) acres more or less.

Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, and all of our right, title, interest, claim, possession or demand, of any kind whatever, whether at law or equity, of, in or to the above described premises, and each and every part and parcel thereof.

To have and to hold the same unto the said Antonio Del Gross and to his heirs and assigns forever, and we do hereby covenant with the said grantee his heirs and assigns, that at the date hereof we are well seized in fee simple of the premises above conveyed, and we will and our heirs, executors and administrators shall warrant and defend the title thereto against the lawful claims or demands of any person or persons whomsoever.
