TO ALL WHOM THESE PRESENTS MAY CONCERN:

BE IT KNOWN, THAT I, H. A. PITTENGER OF COOKS, WASH. IN SAID COUNTY AND STATE, DO HEREBY PUBLISH AND DECLARE, AS A LEGAL NOTICE TO ALL THE WORLD

I. THAT I HAVE A LEGAL RIGHT TO THE USE, POSSESSION AND CONTROL OF AND CLAIM ONE CUBIC FOOT FLOW PER SECOND OF TIME OF THE WATERS OF STREAM ON PREMISES HEREAFTER DESCRIBED IN SAID COUNTY AND STATE FOR IRRIGATION AND OTHER PURPOSES.

II. THAT THE SPECIAL PURPOSE FOR WHICH SAID WATER IS INTENDED TO BE USED, AND THE PLACE OF INTENDED USE IS

I CLAIM THE WATER FOR DOMESTIC USE AND IRRIGATION AND I INTEND TO USE IT ON LOT 6 OF OREGON LUMBER CO'S SUBDIVISION OF A PART OF SECTION 14, TOWNSHIP 3 NORTH RANGE 9 EAST OF WILLAMETTE MERIDIAN IN SKAMANIA CO. WASH. CONTAINING 20 ACRES ACCORDING TO PLAT OF SAID SUBDIVISION FILED AND RECORDED IN OFFICE OF CLERK OF SAID COUNTY

III. THAT I HAVE TAKEN SAID WATER OUT OF, AND DIVERTED IT FROM SAID STREAM BY MEANS OF A DITCH WHICH SAID DITCH IS 12 INCHES BY 12 INCHES IN SIZE AND CARRIES OR CONDUCTS 2 CUBIC FEET FLOW PER SECOND OF TIME OF WATER FROM SAID STREAM; SAID DITCH TAPS AND DIVERTS THE WATER FROM SAID STREAM AT A POINT UPON ITS EAST BANK 366 FEET WEST AND 393 FEET SOUTH OF S.W. CORNER OF THE S.E. 1/4 OF N.W. 1/4 OF SECTION 14 TOWNSHIP 3 NORTH OF RANGE 9 EAST OF WILLAMETTE MERIDIAN IN SAID SKAMANIA CO. AND STATE OF WASHINGTON.

THIS BEING THE SAME DITCH USED BY ONE R. L. FOWLER WHOSE CLAIM OF WATER RIGHT IS ON FILE AND WITH WHOM I HAVE AN AGREEMENT TO TAKE THE WATER, FOR SAID USES, FROM SAID STREAM AT THE SAME POINT. THENCE RUNNING, OR TO RUN, TO AND UPON SAID DESCRIBED LAND (AND THROUGH SAID LAND IF I SO DESIRE TO ANY REQUISITE POINT OF FINAL DISCHARGE).

IV. THAT I APPROPRIATED AND TOOK SAID WATER ON THE 18 DAY OF JULY A.D. 1911, BY MEANS OF SAID DITCH NOTICE POSTED AT POINT OF DIVERSION OF WATER

V. THAT THE NAME OF THE APPROPRIATOR OF SAID WATER IS H. A. PITTENGER

VI. THAT I ALSO HEREBY CLAIM SAID DITCH AND THE RIGHT OF WAY THEREFOR, AND FOR SAID WATER BY IT CONVEYED, OR TO BE CONVEYED, FROM SAID POINT OF APPROPRIATION TO SAID LAND OR POINT OF FINAL DISCHARGE, AND ALSO THE RIGHT OF LOCATION UPON ANY LANDS OF ANY DAMS, FLUMES, RESERVOIRS, CONSTRUCTED OR TO BE CONSTRUCTED, BY ME IN APPROPRIATING AND IN USING SAID WATER.

VII. THAT I ALSO CLAIM THE RIGHT TO KEEP IN REPAIR AND TO ENLARGE SAID MEANS OF WATER APPROPRIATED AT ANY TIME, AND THE RIGHT TO DISPOSE OF THE SAID RIGHT, WATER, DITCH, OR SAID APPURTENANCE, IN PART OR WHOLE, AT ANY TIME.

CLAIMING THE SAME, ALL AND WHOLLY, UNDER ANY AND ALL LAWS, NATIONAL AND STATE, AND THE RULINGS AND DECISIONS THEREUNDER, IN THE MATTER OF WATER RIGHTS.
