State of Washington in consideration of Two Hundred Dollars, to us in hand paid, the receipt whereof is hereby acknowledged, have bargained, sold, and conveyed, and by these presents do bargain, sell and convey unto A. B. Wright of Washington, Black Diamond, the following described premises, to-wit: The West 30 acres of the N.W. 1/4 of S. 36 1/4 of Section (8) of T(11) R. 5. E. of the Willamette Meridian ^{not particularly described} as follows: Commencing at the 1/4 corner just Between Section 37 and 38 T(11) R. 5. E. Willamette Meridian. Running thence south (20) chains thence East 1/2 chains ^{and} thence North (20) chains - thence West (15) chains to the place of Beginning ^{and} containing Thirty acres. Together with tenements, hereditaments, and appurtenances thereto belonging or in anywise appertaining. To have and to hold the same with the appurtenances thereto belonging unto the said A. B.
