NOTICE IS HEREBY GIVEN that on the first day of April 1974 John A. Hope at the request of William N. Dielschneider commenced to perform labor upon:

the following described real estate in Skamania County, Washington:

Government lots 1, 2, 5, 6, 7 and 8; the west 660 feet of the Jas. M. Findley D.L.C.; the northwest quarter of northeast quarter; the northeast quarter of northwest quarter; that portion of the northeast quarter of northeast quarter lying southwesterly of the county road known and designated as the Girl Scout Road, ALL in Section 36, Township 3 North, Range 8, East, W.M., EXCEPT that portion of said Government lot 8 described as follows: Beginning at the northeast corner of said Government lot 8; thence south along the east line thereof 840 feet to intersection with the county road; thence northwesterly following said county road to a point 885 feet west of the point of beginning; thence east 885 feet to the point of beginning.

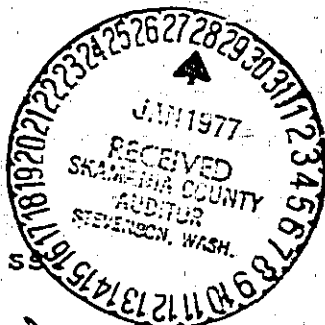
Those portions of the southwest quarter of Section 25, Township 3 north, Range 8 east, W.M. described as follows: Beginning at the quarter corner on the south line of said Section 25; thence north 330 feet; thence west 1320 feet; thence south 330 feet; thence east 1320 feet to the point of beginning; EXCEPT the following described tract: Beginning at a point 110 feet north of the point of beginning located on the northerly line of the Rock Creek and Collins Road; thence north 220 feet; thence west 140 feet to intersection with the northerly line of said road; thence following the northerly line of said road in a southeasterly direction to the point of beginning.

Beginning at a point 330 feet north and 180 feet west of the quarter corner on the south line of said Section 25, said point being located on the southerly line of Rock Creek and Collins Road; thence west 1140 feet to a point on the southerly line of said road, thence in a northeasterly direction following the southerly line of said road 690 feet; thence in a southeasterly direction following the southerly line of said road 450 feet to the point of beginning.
