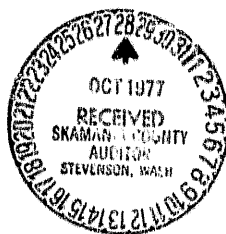

LIEN ON TIMBER AND LUMBER

NOTICE IS HEREBY GIVEN that Kurt Miller and Gordon Walters of Skamania County, State of Washington, claim a lien upon all saw logs, spars, piles, or other timber or lumber manufactured therefrom purchased by Louisiana-Pacific Corporation from the U.S. Forest Service pursuant to a timber sale contract with the United States Forest Service, United States Department of Agriculture, Gifford Pinchot National Forest in the Mt. Adams Ranger District being contract No. 02090-6 known as the "Wind" sale being about 500,000 board feet in quantity, which was cut or manufactured in Skamania County, State of Washington and marked with a paint of a yellow color and branded with a registered brand of "3/SC", and which are now lying in Wind River, Skamania County, Washington, Home Valley, Washington and at the Cascade Locks Lumber Company, Cascade Locks, Oregon, for labor performed upon and assistance rendered in behalf of Louisiana-Pacific Corporation, and their agents, Krohn Logging, Inc., and Ronald Calkins by said Kurt Miller and Gordon Walters; that the name of the owner or reputed owner is Louisiana-Pacific Corporation; that Ronald Calkins on behalf of Krohn Logging, Inc. and Louisiana-Pacific Corporation employed said Kurt Miller and Gordon Walters to perform such labor and render such assistance upon the following terms and conditions,

to-wit; the said Ronald Calkins, on behalf of Krohn Logging, Inc. and Louisiana-Pacific Corporation, agreed to pay said Kurt Miller and Gordon Walters for such labor and assistance the sum of \$9.00 per thousand board feet for falling and bucking of said timber; that said contract has been faithfully performed and fully complied with on the part of said Kurt Miller and Gordon Walters, who performed labor upon and assisted in falling and bucking said timber under the "Wind" sale for the period of thirty (30) days; that said labor and assistance were so performed and rendered upon said "Wind" sale between the 8th day of September, 1977 and the 30th day of September, 1977; and the rendition of said service was closed on the 30th day of September, 1977, and thirty (30) days have not elapsed since that time; that the amount of claimants' demand for said service is \$4,500.00; that no part thereof has been paid except \$2,300.00 and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$2,200.00, which amount they claim as a lien upon said saw logs, spars and piling and manufactured timber therefrom. The said Kurt Miller and Gordon Walters also claim their lien on all said saw logs, spars and pilings now owned by said Louisiana-Pacific Corporation, Krohn Logging, Inc. and Ronald Calkins of said county to secure payment for the work and labor performed in obtaining or securing the said saw logs, spars, piles or other timber herein described.
