

# Notice of Water Appropriation

Notice is hereby give that the undersigned citizen of the United states has this day appropriated from the waters of the East Canon creek,a south fork of the Cispus River 800 cubic feet pf water per cent of time,said water to be diverted at or near the point where a notice of this copy is posted the same being on a large cedar tree on the right shore about two miles above its junction with the main Cispus river and sid water to be carried along the right bank in an easterly direction about five miles to the Mount Adams fork of the cispus river and discharged therein.The means of diversion and conveyance to be by dams,flumes,pipes conduits ditches and siphons.The purpose for thwich this water is appropriated are for mining,milling ,manufacturing,industrial,irrigation and the development of electrical power for furnishing towns and cities with light,heat and power and for furnishing public sservice corporations with light heat and power and for all other public uses to which it can be applied.Appropriated and notice posted this 28th day of April 1910.A cooy of this notice is filed for record with the Auditor of Lewis County
