Beginning in 1975, the county assessor is directed by RCW Chapter 187 to assess and value as <u>CLASSIFIED FOREST LAND</u>, all lands of 20 or more acres which are primarily devoted to, and used for, the growing and harvesting of timber.

This land has been <u>classified</u> as <u>forest land</u> as of January 1, 1975 and will nontinue to be assessed as <u>CLASSIFIED</u> <u>FOREST LAND</u> until removal of such classification for one of the following reasons:

- (a) Notice from owner to remove classification;
- (b) Sale to an ownership making land exempt from taxation;
- (c) Determination by assessor that land is no longer primarily devoted to, and used for, growing and harvesting
- (d) Determination that a higher and better use exists for the land than growing and harventing timber.
