KNOW ALL MEN BY THESE PRESENTS, That I, Mary M. Bingham of Portland, Oregon have made, constituted and appointed, and by these Presents, do make, constitute and appoint Melville R. Bingham, my true and lawful attorney for me and in my name, place and stead to collect and receive any and all debts, dues, demands, obligations, choses, inaction, and other claims of whatever name or nature belonging to me and to give all necessary receipts, discharges, acquittances therefor and to sign my name thereto: And for me and in my name, place and stead to sell, assign, transfer and deliver to the purchaser or purchasers thereof, any and all certificates of stock or other securities which I may hold, own or possess, and to sign my name thereto and receive the purchase price thereof: And for me and in my name, place and stead to transfer, sell, assign and deliver to the purchaser or purchasers thereof any and all bonds, mortgages or other securities or obligations of whatever name or nature which I may hold, own or possess, and to sign my name thereto, and to collect and receive the moneys thereon: And for me and in my name, place and stead to grant, bargain, sell and convey any and parcels of land, real estate or interest therein in the State of Oregon or elsewhere, which I own or possess or in which I have any right or interest, and for me and in my name to make, execute, acknowledge and deliver good and sufficient deeds and conveyances of the same: and to receive the purchase price thereof: And generally, for me and in my name, place and stead to do and transact any business and to execute any papers, which I might do or execute if personally present and for me and in my place and stead to draw any moneys that I may have on deposit in any Bank deposit company or other institution, and to sign my name to any checks, drafts or other paper, necessary therefor, hereby giving and granting unto my said attorney full power and authority to do and perform all and every act or thing whatsoever requisite and necessary to be done in and about the premises, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney or his substitute shall lawfully do or cause to be done by virtue thereof.
