

2. The last levy rate extended against subject land (dollars per thousand)	\$ 9.20/1000
3. Line 1 multiplied by line 2 . . . . .	\$ 111.71
4. Amount of tax last levied on subject land as forest land	\$ 10.00
5. Line 3 less line 4 . . . . .	\$ 101.71
6. Number of years subject land was assessed as forest land; not to exceed ten years (if classified forest land under RCW 84.33.120, years prior to 1978 not included)	3
7. COMPENSATING TAX DUE (line 5 multiplied by line 6) . . . . .	\$ 305.13
8. County Auditor's recording fee for filing Notice of Removal of Classification (RCW 84.33.120) or Designation (RCW 84.33.140)	\$ 3.00



The tax shown herein shall be due and payable to the County Treasurer on or before April 30, 1979. The tax shall become a lien on this land and shall be subject to foreclosure in the same manner as provided in RCW 84.64.050, and shall be charged interest at the same rate as applied by law to delinquent ad valorem property taxes from the due date shown above.
