

George F. Holman . . . to . . . Jonathan Bourne Jr.

This Indenture, Made the Eighth day of October, in the year of our Lord one thousand nine hundred between George F. Holman (unmarried), party of the first part, and Jonathan Bourne Jr. the party of the second part, witnesseth: That the said party of the first part, for and in consideration of the sum of Fifty Dollars gold coin of the United States of America, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained, sold, remised, released and forever quitclaimed, and by these presents do grant, bargain, sell, remise, release and forever quitclaim unto the said party of the second part, and to his heirs and assigns: that certain quartz mining claim situated in Township Three (3) North of Range Five (5) East of the Willamette Meridian, in the Bald Mountain Mining District in the County of Skamania, State of Washington, named and known as the "Limonite" claim, the amended location notice of said "Limonite" claim being recorded in Book "D", at page 344, of Miscellaneous records of said Skamania County, together with all the dips, spurs, and angles, and also all the metals, ores, gold and silver bearing quartz, rock and earth therein; and all the rights, privileges and franchises thereto incident, appendant and appurtenant, or therewith usually had and enjoyed; and also all and singular the tenements, hereditaments, and appurtenances thereto belonging or in anywise appertaining, and the rents, issues and profits thereof; and also all the estate, right, title, interest, property, possession, claim and demand whatsoever, as well in law as in equity, of the said party of the first part, of, in or to the said premises, and every part and parcel thereof, with the appurtenances.

To have and to hold, all and singular the said premises, together with the appurtenances and privileges thereto incident, unto the said party of the second part his heirs and assigns forever.
