Certificate of Water Right.

This is to certify, that Mrs. Austin W. Gray, of Silver Springs, State of Arkansas, has made proof to the satisfaction of the State Supervisor of Hydraulics of Washington, of a right to the use of the waters of unnamed springs a tributary of Lind River, for the purposes of irrigation and domestic supply, under a appropriation permit No. 228, of the State Supervisor of Hydraulics, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Hydraulics of Washington and entered of record in Volume 2, at page 653, on the 6th day of January, 1933; that the right hereby confirmed dates from August 7th, 1928; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes,
