Now it is agreed by said mortgagors that if the mortgagor be compelled to foreclose this mortgage by reason of any breach of the agreement herein contained, the mortgagors shall be entitled to a reasonable attorney's fee in said suit or action, and the mortgagors jointly and severally agree to pay said sums of money hereby named, and agree that a deficiency judgment may be had against said mortgagors R. T. Mills and Charlotte Mills in a suit or action to foreclose this mortgage by the holder of the aforesaid note, or he may waive his security and recover directly upon said note.
