 Certificate of Water Right.

This is to certify, that Joseph Szydio, of Stabler, State of Washington, has made proof to the satisfaction of the State Supervisor of Hydraulics of Washington, of a right to the use of the waters of U named springs a tributary of _____, for the purposes of domestic supply, under appropriation permit No. 1325, of the State Supervisor of Hydraulics, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Hydraulics of Washington, and entered of record in Volume 2, at page 736, on the 6th day of October, 1933; that the right hereby confirmed dates from January 17th, 1933, that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic feet per second.
