D. B. Ambler et ux to C. F. King et al

D. B. Ambler and Adelle M. Ambler do hereby assign and convey the water rights held by them on the springs on the east side of the Washougal River in Skamania County, Washington, covered by Certificate No. 2, Page No. 602 for Skamania County, to C. F. King and Libby King; also joint rights the said D. B. Ambler and Adelle M. Ambler may have over other people's ground along the present pipe line on the east side of the Washougal River, for the purpose of repairing said pipe line, providing no damage is done to any property.

All the foregoing agreement is subject to the rights of Harold A. Smith to pay one-third of the total cost of said pipe line and right of way and own a one-third interest in the same. Thirty-five dollars (\$35.00) have been paid to said Harold A. Smith.

It is also a part of this agreement that D. B. Ambler and Adelle M. Ambler and their heirs and assigns are to have the right to connect a 3/4" pipe to the pipe line from said springs and run the same to the land now owned by D. B. Ambler and Adelle M. Ambler, and use the water permanently, without expense to them.
