### CERTIFICATE OF CHANGE OF POINT OF DIVERSION OF WATER

In accordance with the provisions of Chapter 117, Laws of Washington for 1917, and the regulations of the State Supervisor of Hydraulics thereunder.

THIS IS TO CERTIFY That R. L. Fowler of Cook, Washington, has complied with all of the requirements of Section 39 of the Water Code and is hereby granted a permit to change the point of diversion of 0.42 c.f.s. of the waters of Bunker Creek from a point within the SW $\frac{1}{4}$  or SE $\frac{1}{4}$  of Sec. 15, Twp. 5 N., Rge. 9 E.W.M. to a point within the N $\frac{1}{2}$  of NE $\frac{1}{4}$  of SE $\frac{1}{4}$  of Sec. 18, Twp. 3 N., Rge. 9 E.W.M., such point being approximately 45 rods below the present point of diversion, all in Skamania County, Washington.
