This is to certify, that H.E. Walthers of Cook, State of Washington, has made proof to the satisfaction of the State Supervisor of Hydraulics of Washington, of a right to the use of the waters of Srenocer Creek, a tributary of Bunker Creek, for the purposes of domestic supply, fish culture and irrigation under appropriation Permit No. 2520 issued by the State Supervisor of Hydraulics, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Hydraulics of Washington, and entered of record in Volume 2, at Page 1003, on the 17th day of June, 1937; that the right hereby confirmed dates from July 20, 1936; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.1 cubic feet per second.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or if for other purposes, the place where such water is put to beneficial use, is as follows:
