"IT IS FURTHER RESOLVED: THAT the trustee may, after the assets have been converted into cash, proceed to apply to the court for authority to declare a first dividend and a second dividend, if the same is required, without notice to creditors."

Bruckart, Forest Supervisor, Columbia National Forest of Vancouver, State of Washington, has made proof to the satisfaction of the State Supervisor of Hydraulics of Washington, of a right to the use of the waters of Lost Creek, a tributary of _____ for the purposes of Domestic supplies, recreational development, water for grazing stock and fire protection, under Appropriation Permit No. 2118 issued by the State Supervisor of Hydraulics, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Hydraulics of Washington and entered of record in Volume 2, at Page 1009, on the 9th day of July, 1937; that the right hereby confirmed dates from August 12, 1935; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.0 cubic feet per second.
