The Grantors, L. M. Sallee and H. M. Sallee, his wife, and W. W. McBredie and Alice H. McBredie, his wife, for a valid consideration in hand paid, convey and quit claims to L. M. Hadden, Trustee, the Climax Lode or Mine, situated in what would be if surveyed, the West 1/2 of Section 30, in Twp. 4 North of Range 5 East of T. M. Skamania County, Washington, and bounded and described as follows, to-wit: -

Beginning at the Discovery Post which is on the West bank of Canyon Creek about 1 and 1/2 miles above the forks of said Canyon Creek and Lewis River in Clarke County, Washington, running thence in a Southerly direction about 20 deg. East along a blazed line 300 feet to South East corner stake; thence in a Westerly direction 20 deg. South along a blazed line 1500 feet to South West corner stake; thence in a Northerly direction about 20 deg. West 600 feet to North West corner stake; thence in an Easterly direction about 20 deg. North 1500 feet to the North East corner stake; thence in a Southerly direction 20 deg. East 300 feet to the place of beginning.
