

I promise and agree to pay, in addition to the costs and disbursements provided by statute, such additional sum, in like Gold coin, as the court may adjudge reasonable for attorney's fees to be allowed in said suit or action.

And said mortgagors hereby covenant that bessie jackson is the owner of said premises in fee simple that they are free from all incumbrances that she will pay all taxes upon said premises at least ten days before the same become delinquent. That she will keep the buildings erect, and to be erected upon said premises insured against fire in a sum not less than One Thousand (\$1000.00) Dollars, in a company acceptable to said mortgagee, and the loss, if any, made payable to said mortgagee, as her interest may appear.

Now if the payment of said note, interest, taxes and insurance premiums as herein provided, shall render this conveyance void, but in case default is made in the payment of the interest in said note expressed when the same shall become due, or failure to pay the taxes as herein provided, or in default of the performance of any of the covenants or conditions as herein expressed on the part of the mortgagor, then the whole of the principal sum and the interest accrued at the time default is made or declared, and all taxes upon said premises which the holder of said note shall have paid, or become liable to pay, shall, at the option of the holder of said note, become due and payable, and this mortgage may be foreclosed at any time thereafter.

Now it is agreed by said mortgagors that if the mortgagee be compelled to foreclose this mortgage by reason of my breach of this agreement herein contained, the mortgagors shall be entitled to a reasonable attorney's fee in said suit or action, and the mortgagors agrees to pay said sum of money hereby secured and agrees that a deficiency judgment may be had against said mortgagors in a suit or action to foreclose this mortgage by the holder of the aforesaid note, or she may waive his security and recover directly upon said note.
