I further authorize and direct the said Clara Anderson, for me and in my name, place and stead, to transact any or all business in which I may be engaged or in which I may have any interest whatsoever, and to exercise all right, power and authority which I could exercise if personally present and acting.

And I do further authorize and empower my said attorney in fact to sell a part of my real or personal property as aforesaid upon such terms as to her may seem meet and proper and to borrow money upon said real or personal property in such amounts and upon such terms as shall to her seem meet and proper, and I do ratify all that my said attorney in fact may do or cause to be done by virtue hereof.

It is my intention to hereby confer full and general power upon my said attorney in fact, to transfer for me and in my name, place and stead, business of every kind and character and to in all respects represent me upon the terms and conditions deemed by her to be meet and proper.
