THIS IS TO CERTIFY, THAT LEE HAMILTON, OF COOK, STATE OF WASHINGTON,
HAS MADE PROOF TO THE SATISFACTION OF THE SUPERVISOR OF HYDRAULICS OF WASHINGTON,
OF A RIGHT TO THE USE OF THE WATERS OF BERRY CREEK, FOR THE PURPOSES OF OF IRRIGA-
TION AND DOMESTIC USES, UNDER APPROPRIATION PERMIT NO. 269, OF THE SUPERVISOR OF HYDRAU-
LICS, AND THAT SAID RIGHT TO THE USE OF SAID WATERS HAS BEEN PERFECTED IN ACCORDANCE
WITH THE LAWS OF WASHINGTON, AND IS HEREBY CONFIRMED BY THE SUPERVISOR OF HYDRAULICS
OF WASHINGTON AND ENTERED OF RECORD IN VOLUME ONE, AT PAGE 44, ON THE 7TH DAY OF MAY,
1923; THAT THE RIGHT HEREBY CONFIRMED DATES FROM OCTOBER 5, 1921, THAT THE AMOUNT OF

NOT EXCEED 0.5 CUBIC FEET PER SECOND.
